13 The Arizona Department of Financial Institutions' Superintendent has reviewed the
14 Motion for Default and Proposed Findings of Fact, Conclusions or Law and Order (the
15 "Motion") submitted by the Office of the Arizona Attorney General on behalf of the Arizona
16 Department of Financial Institutions ("Department"). The Superintendent has confirmed that
17 all necessary parties were properly served the Motion, procedural due process has been
18 followed, and there is sufficient cause to rule on this matter, which allows for the following to
19 be issued:

21 The Superintendent adopts the Motion's Findings of Facts No. 1 through 21 in their

24 The Superintendent adopts the Motion's Conclusions of Law No. 22 through 29 in their

1 ORDER

2 **IT IS ORDERED, ADJUDGED, OR DECREED THE FOLLOWING:**

3 1. That Michael Allan Robinson, Jr. has failed to provide an Answer to the
4 Department's Notice of Hearing and Complaint issued to him and is in default;

5 2. That the Department's Motion is granted;

6 3. That Michael Allan Robinson, Jr.'s Arizona loan originator license No. 0927358
7 be immediately revoked;

8 4. That Michael Allan Robinson, Jr. is fined the amount of **eight hundred seventy-**
9 **seven dollars and fifty cents (\$877.50)** to pay for the mandatory examination fee, in
10 accordance with A.R.S. § 6-125;

11 5. That the Department pursues all legal and necessary actions to notify those
12 entities or individuals that Michael Allan Robinson, Jr.'s Arizona loan originator license has
13 been revoked; and

14 6. That the administrative hearing before the Office of Administrative hearing
15 scheduled for December 22, 2016 is immediately vacated because there is no case in
16 controversy before that tribunal.

17 NOTICE

18 The parties are advised that, under A.R.S. § 41-1092.09, this is a Final Order or Final
19 Judgment, unless a party submits a written motion to the Superintendent for a rehearing no
20 later than thirty (30) days after service of this decision. A motion for rehearing must specify
21 the particular reason(s) for the rehearing or review in accordance with A.A.C. R20-4-1219(C).
22 A copy of the motion for rehearing must be served upon all the other parties to the hearing,
23 including the Attorney General's Office. In the alternative, the parties are advised they may


