CONCLUSIONS OF LAW

1. The Director has jurisdiction over this matter.


2. Respondent's conduct constitutes the failure to notify the Department within twenty-four (24) hours of the employment of a bail recovery agent within the meaning of A.R.S. §20-323.

3. Grounds exist for the Director to suspend, revoke or refuse to renew Respondent's license, impose a civil penalty upon Respondent and/or order restitution, pursuant to A.R.S. §20-316 (C).

ORDER

IT IS ORDERED THAT Respondent shall pay a civil penalty of two hundred fifty dollars (\$250) to the Director payable upon entry of this Order for remission to the State Treasurer for deposit in the State General Fund.




