

1 insurance adjuster license, National Producer Number 16823845. Respondent's license is
2 scheduled to expire on September 30, 2021.

3 5. Respondent's business and mailing address of record with the Department is
4 10168 South Barnsley Lane, South Jordan, UT 84009. Respondent's business e-mail address
5 of record with the Department is Shelly.Stephens@sedgwickcms.com.

6 6. On July 23, 2020, Respondent, by and through her attorney, notified the
7 Department that she omitted material information from her 2017 license application;
8 specifically, on February 27, 2017, she was convicted in the state of Utah of a third degree
9 felony.

10 7. Per the April 13, 2017 Judgment, Sentence, Commitment Order of the Third
11 District Court - West Jordan, State of Utah, Respondent was found guilty and convicted for
12 "unlawful sexual misconduct with 16 or 17 year old (amended), a third degree felony. The
13 Court ordered Respondent to a term of 60 days in jail with credit for one (1) day served, and
14 placed Respondent on probation for 60 months. At a Probation Review Hearing on
15 September 24, 2019, the Court terminated the Respondent's probation and closed her case.

16 CONCLUSIONS OF LAW

17 1. The Director ("Director") has jurisdiction over this matter.

18 2. Respondent's conduct, as described above, constitutes providing incorrect,
19 misleading, incomplete or materially untrue information in the license application, within the
20 meaning of A.R.S. § 20-295(A)(1).

21 3. Respondent's conduct, as described above, constitutes having been convicted
22 of a felony, within the meaning of A.R.S. § 20-295(A)(6).

1 3. Respondent is aware of her right to notice and to a hearing, at which she may
2 be represented by counsel, present evidence and examine witnesses.


3 4. Respondent irrevocably waives her right to such notice and hearing and to any
4 court appeals relating to this Consent Order.

5 5. Respondent states that no promise of any kind or nature whatsoever, except as
6 expressly contained in this Consent Order, was made to induce her to enter into this Consent
7 Order and that she has entered into this Consent Order voluntarily.

8 6. Respondent acknowledges that the acceptance of this Consent Order by the
9 Director is solely to settle this matter against her and does not preclude any other agency,
10 officer, or subdivision of this state including the Department from instituting civil or criminal
11 proceedings as may be appropriate now or in the future not related to this matter.

12 7. Respondent acknowledges that this Consent Order is an administrative action
13 that the Department will report to the National Association of Insurance Commissioners
14 (NAIC). Respondent further acknowledges that she must report this administrative action to
15 any and all states in which she holds an insurance license and must disclose this
16 administrative action on any license application.
