7 The State of Arizona Department of Insurance ("Department") has received evidence
8 that James G. Kent ("Respondent") violated provisions of Title 20, Arizona Revised Statutes.
9 Respondent wishes to resolve this matter without the commencement of formal proceedings,
10 and admits the following Findings of Fact are true and consents to entry of the following
11 Conclusions of Law and Order.

FINDINGS OF FACT

12
13 1. Respondent is, and was at all material times, licensed as a non-resident
14 Life/Health/Accident producer, Arizona license number 155424, which license expires June
15 30, 2005.

16 2. On October 2, 2003, the Illinois Department of Insurance issued an 'Order of
17 Revocation' revoking Respondent's Illinois resident insurance license effective 30 days from
18 the date of the order and alleged that he improperly converted monies received in the course
19 of doing insurance business, intentionally misrepresented the terms of an actual insurance
20 contract, and demonstrated untrustworthiness and financial irresponsibility in the conduct of
21 business.

1 **CONCLUSIONS OF LAW**

2 1. The Director has jurisdiction over this matter.

3 2. Respondent's conduct as described above constitutes using fraudulent, coercive
4 or dishonest practices, or demonstrating incompetence, untrustworthiness or financial
5 irresponsibility in the conduct of business in this state or elsewhere within the meaning of
6 A.R.S. § 20 -295(A)(8).

7 3. Respondent's conduct as described above constitutes having an insurance
8 producer license, or its equivalent, denied, suspended or revoked in any other state, province,
9 district or territory within the meaning of A.R.S. § 20 -295(A)(9).

10 4. Grounds exist for the Director to suspend, revoke, or refuse to renew
11 Respondent's insurance license, impose a civil penalty and/or order restitution pursuant to
12 A.R.S. §§20-295(A) and 20-295(F).

13 **ORDER**

14
15 IT IS HEREBY ORDERED THAT Respondent's license is revoked effective
16 immediately upon entry of this Order.

10 4. Respondent states that no promise of any kind or nature whatsoever, except as
11 expressly contained in this Consent Order, was made to him to induce him to enter into this
12 Consent Order and that he has entered into this Consent Order voluntarily.

13 5. Respondent acknowledges that the acceptance of this Consent Order by the
14 Director is solely to settle this matter against him and does not preclude any other agency,
15 officer, or subdivision of this state from instituting civil or criminal proceedings as may be
16 appropriate now or in the future.
