The State of Arizona Department of Insurance ("Department") has received evidence that Frank DeWayne Kaylor has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Frank DeWayne Kaylor ("Respondent" or "Kaylor") is, and was at all material times licensed as a non-resident casualty, accident/health, life and property producer, Arizona license number 49472, which license expires March 31, 2006.
- 2. Kaylor's addresses of record with the Department are: c/o Security Insuance Agency, Inc., 131 E. Wisconsin Ave. #102, Pewaukee, Wisconsin 53072 (business) and N26 W27058 Prospect Ave., Pewaukee, Wisconsin 53072 (residence).
- 3. On or about January 6, 2006, the Department obtained information regarding the status of Kaylor's resident license.
- 4. On December 14, 2005, In the Matter of Frank D. Kaylor, Case No. 05-C29440, the Wisconsin Commissioner of Insurance ordered Kaylor's license suspended for six months or until he makes restitution and the required accounting, whichever is longer.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction over this matter.
- 2. Respondent is not currently licensed as a resident and in good standing in his home state within the meaning of A.R.S. § 20-287(A)(1).
- 3. Respondent's conduct as described above constitutes having an insurance producer license suspended in any other state within the meaning of A.R.S. § 20-295(A)(9).
- 4. Respondent's conduct as described above constitutes violating any provision of this title or any rule, subpoena or order of the director within the meaning of A.R.S. § 20-295(A)(2).
- 5. Grounds exist for the Director to suspend, revoke, or refuse to renew Respondent's insurance license, impose a civil penalty and/or order restitution pursuant to A.R.S. §§20-295(A)&(F).

ORDER

IT IS HEREBY ORDERED THAT:

1. Respondent's non-resident authority under license number 49472 is immediately suspended.
