

1 Fingerprint Replacement Form” on or before March 21, 2006.

2 5. On April 4, 2006, the Department sent a second letter to Erlach, at her
3 business address of record, return receipt requested, notifying her that she had fifteen (15)
4 days to submit a full set of fingerprints to the Department.

5 6. The February 13, 2006 letter was refused and the April 4, 2006 letter was
6 returned “Attempted Not Known”. To date, Erlach has not submitted a full set of fingerprints
7 to the Department.

8 **CONCLUSIONS OF LAW**

9 1. The Director has jurisdiction over this matter.

10 2. Erlach’s conduct as described above, constitutes the violation of the
11 requirement that an applicant submit a full set of fingerprints to the Department within the
12 meaning of A.R.S. § 20-285(F)(2).

13 3. Erlach’s conduct as described above constitutes providing incomplete
14 information in the license application in violation of A.R.S. § 20-295(A)(1).

15 4. Erlach’s conduct as described above constitutes the violation of any provision
16 of A.R.S. Title 20 or any rule, subpoena or order of the director within the meaning of
17 A.R.S. § 20-295(A)(2).

18 5. Grounds exist to suspend, revoke or refuse to renew Erlach’s insurance
19 license pursuant to A.R.S. §§ 20-295(A)(1) and (A)(2).

21 **ORDER**

22 **IT IS ORDERED:**

23 1. Erlach is assessed a civil penalty in the amount of \$ 100.00 due and payable
24 upon return of the Consent Order.

25 2. Erlach must immediately submit a replacement set of fingerprints along with a
26 completed “Illegible Fingerprint Replacement Form” to the Department.

1 Order, her resident insurance producer's license, Arizona license number 853510, is
2 revoked.


