10	FINDINGS OF FACT
11	Wellcare Prescription Insurance, Inc. ("Petitioner"), a Florida domiciled insurer, was
12	issued its certificate of authority to transact disability insurance in Arizona effective February 1
13	2006.
14	2. In accordance with A.R.S. §§ 20-230 and 20-582(3), the Director ordered Petitioner
15	to make a retaliatory deposit with the Arizona State Treasurer ("Retaliatory Deposit"). The
16	approximate current balance of the Retaliatory Deposit is \$110,000 (One hundred ten
17	thousand dollars).
18	3. Upon a review of all existing retaliatory deposits, the Arizona Department of
19	Insurance determined that Petitioner's Retaliatory Deposit is no longer required pursuant to
20	A.R.S. § 20-230 and that it is appropriate to release the Retaliatory Deposit to the Petitioner.

1. The Director has no personal liability for the release of such deposit so made by her

1	in good faith as provided in A.R.S. § 20-588(B).
2	2. Petitioner is entitled to the release of its Retaliatory Deposit pursuant to A.R.S.
3	§ 20-230 and 20-588(A)(2).
4	ORDER
5	THEREFORE IT IS ORDERED that Petitioner's Retaliatory Deposit shall be released to
6	Petitioner.
