The State of Arizona Department of Insurance ("Department") has received evidence that **Robert Jusdon Brannon and Treichler-Brannon, Inc.** have violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondents wish to resolve this matter without the commencement of formal proceedings, and admit the following Findings of Fact are true and consent to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Respondent Robert Judson Brannon ("Brannon") is, and was at all material times licensed as a resident producer, Arizona license number 13893.
- 2. Respondent Treichler-Brannon, Inc. ("Treichler-Brannon") is, as was at all material times licensed as a business entity, Arizona license number 783109.
- 3. Brannon is the Secretary and Treasurer and Compliance Representative for Treichler-Brannon.
- 4. On December 22, 2003, the Arizona Corporation Commission issued an Order to Cease and Desist, Order of Disgorgement, Order of Revocation, Order for Administrative Penalties and Consent to Same, In the Matter of: Robert J. Brannon, Docket No. S-03487A-03-0000 ("ACC Order"). In the ACC Order, Brannon was required to cease and desist from

violating the Securities Act, disgorge all sales commissions and pay an administrative penalty. Brannon signed the ACC Order on October 31, 2003.

- 5. On December 29, 2003, the NASD filed an Order Accepting Offer of Settlement. Department of Enforcement v. Robert J. Brannon, CRD No. 810610, Disciplinary Proceeding No. C3A030022 ("NASD Order"). In the NASD Order, Brannon was suspended from association with any member of NASD in any capacity and fined in the amount of \$5,000.00.
- 6. On January 25, 2005, Brannon filed an Insurance License Renewal Application with the Department. Part II, B asks: Have you had any professional, vocational, business license or certification refused, denied, suspended, revoked or restricted, or a fine imposed by any public authority that has not previously been disclosed by you to this agency in a license application? Brannon answered No to this guestion. Brannon signed the application on January 28, 2005.
- 7. On December 18, 2005, Brannon filed an Insurance License Renewal Application for a Business Entity on behalf of Treichler-Brannon. Part II, B asks: Has the applicant or any individual designated in the application as a principal or individual who is to exercise the powers conferred by the license had any professional license, vocational license, business license or certification refused, denied, suspended, revoked or restricted that has not previously disclosed any license application or accompanying statement? Brannon answered No to this question. Brannon signed the application on December 12, 2005.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction over this matter.
- 2. Respondents' conduct as described above constitutes providing incomplete information in the license application within the meaning of A.R.S. § 20-295(A)(1).
