**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Gregory Ray Swarts** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Gregory Ray Swarts ("Respondent") is licensed as a bail bond agent, Arizona License Number 197525 which expires on January 31, 2009.
2. Respondent's address of record with the Department is: 5164 N. Western Blvd., Prescott, Arizona 86314.
2. On April 13, 2006, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled on May 31, 2006.
3. On April 17, 2006, the insurer holding Respondent's surety bond notified Respondent that Respondent's bail agent bond was to be cancelled on May 31, 2006.




1 **ORDER**
