CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that Ronald Neil Cookler has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Ronald Neil Cookler ("Cookler") was licensed as a non-resident life and variable life/variable annuities producer, Arizona license number 113073, until he surrendered that license to the Department on August 16, 2005 to resolve an administrative action against his license.

2. Cookler's mailing/residence address of record with the Department is: 22 Manor Drive, Morristown, New Jersey, 07960. Cooker's business address of record with the Department is: c/o J B Hanaver & Co, 4 Gatehall Dr., Parsippany, New Jersey 07054.

3. On or about February 11, 1982, Cookler executed a consent order, without admitting liability, with the Securities and Exchange Commission *In the Matter of J. B. Hanaver & Co., et al*, ¶ 83,099, Federal Securities Law Reports (1982). Cookler agreed to a forty-five day suspension commencing on March 1, 1982.





1 4. Respondent states that no promise of any kind or nature whatsoever, except as  
2 expressly contained in this Consent Order, was made to him to induce him to enter into this  
3 Consent Order and that he has entered into this Consent Order voluntarily.

4 5. Respondent acknowledges that the acceptance of this Consent Order by the  
5 Director is solely to settle this matter against him and does not preclude any other agency,  
6 officer, or subdivision of this state from instituting civil or criminal proceedings as may be  
7 appropriate now or in the future.
