CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that Traci Delayne Hockett ("Respondent") violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent is, and was at all material times licensed as an Arizona resident property and casualty, life and health, and annuity producer, Arizona license number 91457, which license expires May 31, 2007.
2. On or about September 19, 2006, Respondent created a fraudulent auto insurance I.D. card and provided it to Jim Click Automotive as evidence of coverage in order for her to drive her newly purchased vehicle off the lot.

CONCLUSIONS OF LAW


1. The Director has jurisdiction over this matter.
2. Respondent's conduct as described above constitutes demonstrating incompetence, untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere within the meaning of A.R.S. §20-295(A)(8).

3 4. Respondent states that no promise of any kind or nature whatsoever, except as
4 expressly contained in this Consent Order, was made to her to induce her to enter into this

6 5. Respondent acknowledges that the acceptance of this Consent Order by the
7 Director is solely to settle this matter against her and does not preclude any other agency,
8 officer, or subdivision of this state from instituting civil or criminal proceedings as may be
9 appropriate now or in the future.


