The Arizona Department of Insurance (the "Department") alleges that Sierra Renee Largo has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 1. Sierra Renee Largo ("Respondent") is licensed as a bail bond agent, Arizona License Number 867238 which expires on September 30, 2009.
- 2. Respondent's addresses of record with the Department are: c/o Better Bail Bonds, 3110 N. Scottsdale Rd., Scottsdale, AZ 85251 (business and mailing); and 3319 E. University Drive, #302, Mesa, AZ 85213 (residence).
- On September 20, 2006, the insurer holding Respondent's surety bond notified 3. the Department that Respondent's bail agent bond was to be cancelled thirty days from and after receipt of the notice by certified mail.

- 4. On or about October 20, 2006, the insurer holding Respondent's surety bond cancelled Respondent's bail agent bond.
- 5. On October 25, 2006, the Department notified Respondent at her business/mailing address of record, return receipt requested, that her surety bond had been cancelled.
- 6. On November 4, 2006, someone at Respondent's business/mailing address signed the green card and accepted the Department's October 25, 2006 letter.
- 7. As of October 20, 2006, the Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.
 - 8. The public health, safety and welfare imperatively require emergency action.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction.
- 2. Respondent's conduct constitutes a violation of the requirement that each bail bond agent maintain in force while license a bond in favor of this State executed by a surety insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.
- 3. Grounds exist to order a summary suspension within the meaning of A.R.S. § 41-1092.11(B).

ORDER

IT IS HEREBY ORDERED THAT:

1. Respondent's license is summarily suspended effective immediately.
