**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Sierra Renee**  
10 **Largo** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the  
11 serious nature of these allegations, the Director of Insurance for the State of Arizona  
12 ("Director") finds that the public health, safety and welfare imperatively require emergency  
13 action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

14  
15 1. Sierra Renee Largo ("Respondent") is licensed as a bail bond agent, Arizona  
16 License Number 867238 which expires on September 30, 2009.

17 2. Respondent's addresses of record with the Department are: c/o Better Bail  
18 Bonds, 3110 N. Scottsdale Rd., Scottsdale, AZ 85251 (business and mailing); and 3319 E.  
19 University Drive, #302, Mesa, AZ 85213 (residence).

20 3. On September 20, 2006, the insurer holding Respondent's surety bond notified  
21 the Department that Respondent's bail agent bond was to be cancelled thirty days from and  
22 after receipt of the notice by certified mail.
