- 1. Petitioner, Guaranty National Insurance Company, NAIC No. 11401, is a foreign insurer domiciled in Delaware. Petitioner received its certificate of authority to transact property and casualty insurance in Arizona on August 11, 1982.
- 2. Effective December 28, 2006, Petitioner, the non-surviving entity, merged into Security Insurance Company of Hartford (SICH), NAIC No. 24902, the surviving entity, a foreign insurer domiciled in Delaware. The surviving entity is authorized to transact insurance in Arizona. Petitioner has voluntarily surrendered its certificate of authority to the Director.
- 3. On December 13, 2006, the Insurance Commissioner of Delaware approved the merger of Petitioner into SICH.

Petitioner has no obligations under any policy of insurance to any 1 4. 2 policyholders or claimants who are residents of Arizona. Petitioner is not the subject of any pending investigation or market conduct 3 5. examination, and Petitioner does not owe this Department any filings or fees. 4 Petitioner has deposited \$100.00 which has been credited to the 5 6. Insurance Examiners' Revolving Fund ("IERF") pursuant to A.R.S. § 20-159. 6 7 IT IS ORDERED that: 1. The surrender of the Petitioner's certificate of authority is accepted. 8 2. The \$100.00 deposited by Petitioner which has been credited to the IERF 9 10 shall be released to Petitioner.
