15 Based upon reliable evidence provided to the Director of Insurance by the
16 Assistant Director of the Financial Affairs Division of the Department of Insurance, the
17 Director finds as follows:

- 18 1. Petitioner, Farmers Home Mutual Insurance Company, NAIC No. 13846,
19 is a foreign insurer domiciled in Minnesota. Petitioner received its certificate of authority
20 to transact property and casualty insurance in Arizona on May 2, 1952.
- 21 2. Petitioner seeks to withdraw from the insurance business in Arizona and
22 has voluntarily surrendered its certificate of authority to the Director.
- 23 3. Petitioner has obligations under policies of insurance to policyholders
24 and/or claimants who are residents of Arizona.

1 4. Petitioner has executed a Security Deposit, Assignment and Trust
2 Agreement for the Sole Benefit of Arizona Policyholders and Claimants and has posted
3 a Security Deposit in the amount of \$1,000,000.

4 5. Petitioner is not the subject of any pending investigation or market conduct
5 examination.

6 6. Petitioner's 2006 Annual Statement together with payment of all applicable
7 fees is due to this Department March 1, 2007.

8 7. Petitioner has deposited \$100.00 which has been credited to the Insurance
9 Examiners' Revolving Fund ("IERF") pursuant to A.R.S. § 20-159.

10 IT IS ORDERED that:

- 11 1. The surrender of the Petitioner's certificate of authority is accepted.
12 2. Petitioner shall file its 2006 Annual Statement, together with payment of all
13 applicable fees.
14 3. The \$100.00 deposited by Petitioner which has been credited to the IERF
15 shall be released to Petitioner.


