- Effective December 28, 2006, Petitioner, the non-surviving entity, merged 2. into Valley Forge Life Insurance Company (VFLIC), NAIC No. 70211, the surviving entity, a foreign insurer domiciled in Indiana. The surviving entity is authorized to transact insurance in Arizona. Petitioner has voluntarily surrendered its certificate of authority to the Director.
- 3. On December 27, 2006, the Insurance Commissioner of Texas approved the merger of Petitioner into VFLIC.
