ORDER

Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Financial Affairs Division of the Department of Insurance, the Director finds as follows:

1. Petitioner, American Travelers Assurance Company, NAIC No. 61140, is a foreign insurer domiciled in the District of Columbia. Petitioner received its certificate of authority to transact life and disability insurance in Arizona on November 8, 1984.
2. Petitioner seeks to withdraw from the insurance business in Arizona and has voluntarily surrendered its certificate of authority to the Director.
3. Petitioner has no obligations under any policy of insurance to any policyholders or claimants who are residents of Arizona.
4. Petitioner is not the subject of any pending investigation or market conduct examination.

1 5. Petitioner's 2006 Annual Statement together with payment of all applicable
2 fees is due to this Department March 1, 2007.

3 6. Petitioner has deposited \$100.00 which has been credited to the Insurance
4 Examiners' Revolving Fund ("IERF") pursuant to A.R.S. § 20-159.

5 IT IS ORDERED that:

6 1. The surrender of the Petitioner's certificate of authority is accepted.

7 2. Petitioner shall file its 2006 Annual Statement, together with payment of all
8 applicable fees.

9 3. The \$100.00 deposited by Petitioner which has been credited to the IERF
10 shall be released to Petitioner.
