CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that Jose Jesus Gonzalez and Gonzco Enterprises, LLC dba Gonzco Insurance, ("Respondents") violated provisions of Title 20, Arizona Revised Statutes. Respondents wish to resolve this matter without the commencement of formal proceedings, and admit the following Findings of Fact are true and consent to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Jose Jesus Gonzalez ("Gonzalez") is, and was at all material times licensed as an Arizona resident accident/health, life, property and casualty insurance producer, Arizona license number 73663, which license expires December 31, 2008.

2. Gonzalez is, and was at all material times owner and operator of Gonzco Enterprises, LLC dba Gonzco Insurance . Gonzco Enterprises, LLC is an Arizona Limited Liability Company incorporated on January 2, 2004 which is, and was at all material times licensed as an Arizona resident property and casualty insurance producer, Arizona license number 170136, which license expires February 28, 2010.

6 Conclusions of Law and Order.


7 3. Respondents are aware of their right to notice and a hearing at which they may

13 Consent Order and that they have entered into this Consent Order voluntarily.

14 5. Respondents acknowledge that the acceptance of this Consent Order by the
15 Director is solely to settle this matter against them and does not preclude any other agency,
16 including the Department, officer, or subdivision of this state or this agency from instituting civil
17 or criminal proceedings as may be appropriate now or in the future.


18 6. Gonzalez represents that he is owner and operator of Gonzco Enterprises, LLC
