CONSENT ORDER

Respondent.

The State of Arizona Department of Insurance ("Department") has received evidence that Tracey Lynn Harms ("Respondent") violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

- Respondent is, and was at all material times licensed as an Arizona resident property & casualty insurance producer, Arizona license number 99724, which license expires April 30, 2010.
- Respondent is, and was at all material times employed as an office manager of Arizona Gecko Insurance in Fort Mohave, Arizona.
- 3. Between September 2, 2005 and February 15, 2006, Respondent made unauthorized personal purchases with the agency credit card.
- On August 29, 2006, Respondent entered into a plea agreement, in Superior Court of Arizona, Mohave County, Case No. CR- 2006-0831, pleading guilty to

Theft, a Class 6 Undesignated Offense, reduced from Count 1, Fraudulent Schemes and Artifices.

5. On December 28, 2006, the Superior Court of Arizona, Mohave County, found Respondent guilty of Theft, a Class 6 Undesignated Offense, reduced from Count 1, Fraudulent Schemes and Artifices pursuant to the plea agreement, suspended imposition of sentence, placed Respondent on three years probation, and ordered restitution.

CONCLUSIONS OF LAW

- The Director has jurisdiction over this matter.
- Respondent's conduct as described above constitutes having been convicted of a felony within the meaning of A.R.S.§20-295(A)(6).
- Respondent's conduct as described above constitutes demonstrating incompetence, untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere within the meaning of A.R.S. §20-295(A)(8).
- 4. Grounds exist for the Director to suspend, revoke, or refuse to renew Respondents' insurance license, impose a civil penalty and/or order restitution pursuant to A.R.S. §§20-295(A) and (F).

ORDER

IT IS HEREBY ORDERED THAT

1. Respondent's license is revoked effective immediately upon entry of this Order.
