

1 4. On November 26, 2007, the Department sent Respondent a letter, return receipt
2 requested, at his mailing address of record, notifying Respondent that he had failed to
3 maintain a surety bond as required by law.

4 5. On January 2, 2008, the Department's November 26, 2007 letter was returned
5 by the Post Office as "Unclaimed."

6 6. As of November 16, 2007 (October 19, 2007 plus 30 days), Respondent has not
7 maintained a bond in favor of this State executed by a surety insurer authorized to do
8 business in this State.

9 7. The public health, safety and welfare imperatively require emergency action.

10 **CONCLUSIONS OF LAW**

11 1. The Director has jurisdiction.

12 2. Respondent's conduct constitutes a violation of the requirement that each bail
13 bond agent maintain in force while license a bond in favor of this State executed by a surety
14 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

15 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §
16 41-1092.11(B).

17 **ORDER**

18 IT IS HEREBY ORDERED THAT:

19 1. Respondent's license is summarily suspended effective immediately.

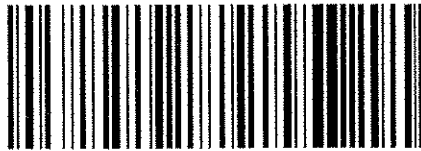

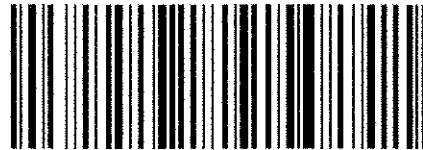

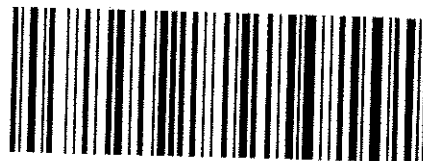
