In the Matter of: No. 08A-058-INS **MOISES YEO** (License number 896712) CONSENT ORDER Hearing 6/10/08, 9:00 a.m. ALJ Michael Wales Respondent

The State of Arizona Department of Insurance ("Department") has received evidence that Moises Yee has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

### FINDINGS OF FACT

- 1. Moises Yeo ("Respondent") is, and was at all material times licensed as a resident credit producer, Arizona license number 896712 which expires May 31, 2011.
- 2. Respondent's mailing, business and residence addresses of record with the Department are: c/o Wells Fargo, 5816 N. 19th Ave., Phoenix, Arizona 85015 (business); 2929 W. Bethany Home Rd., Phoenix, Arizona 85017 (mailing and residence).
- 3. On or about July 20, 2007, the Department issued to Respondent an insurance license as a resident credit producer, Arizona license number 896712.
- On November 19, 2007, the Department notified Respondent by mail at his mailing/residence address of record that his fingerprint card had been processed and returned by the Federal Bureau of Investigation ("FBI") as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before December 20, 2007.
- 5. To date, Respondent has not submitted a full set of fingerprints to the Department.

On April 9, 2008, the Department set a hearing and issued a Notice of Hearing 6. for revocation of Respondent's license.

# CONCLUSIONS OF LAW

- The Director has jurisdiction over this matter. 1.
- Respondent's conduct as described above constitutes the violation of the 2. requirement that an applicant submit a full set of fingerprints to the Department within the meaning of A.R.S. § 20-285(F)(2).
- Respondent's conduct as described above constitutes providing incomplete information in the license application within the meaning of A.R.S. § 20-295(A)(1).
- Respondent's conduct as described above constitutes the violation of any provision of A.R.S. Title 20 or any rule, subpoena or order of the director within the meaning of A.R.S.§20-295(A)(2).
- Grounds exist for the Director to suspend, revoke, or refuse to renew 5. Respondent's insurance license, impose a civil penalty and/or order restitution pursuant to A,R.S. §§20-295(A) and (F).

## ORDER

### IT IS HEREBY ORDERED THAT:

- Respondent shall immediately submit to the Department a full set of fingerprints 1. and an Illegible Fingerprint Replacement Form.
- Respondent shall immediately pay to the Department a civil money penalty in the 2. amount of \$100.
- The hearing, Docket # 08A-058-INS, scheduled for June 10, 2008 at 9:00 a.m. is 3. vacated.

- 6. Respondent acknowledges that this Consent Order is an administrative action that the Department will report to the National Association of Insurance Commissioners (NAIC). Respondent further acknowledges that he must report this administrative action to
