The State of Arizona Department of Insurance ("Department") has received evidence that Erin Margaret Costello has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Erin Margaret Costello ("Respondent") is, and was at all material times licensed as a resident credit producer, Arizona license number 899429 which expires April 30, 2011.
- 2. Respondent's mailing, business and residence addresses of record with the Department are: c/o Wells Fargo, 850 E. Greenway Parkway, Phoenix, Arizona 85022 (business); 8203 W. Oraibi Dr., #2112, Peoria, Arizona 85382 (mailing and residence).
- 3. On or about August 29, 2007, the Department issued to Respondent an insurance license as a resident credit producer, Arizona license number 899429.
- On December 31, 2007, the Department notified Respondent by mail at her 4. mailing/residence address of record that her fingerprint card had been processed and returned by the Federal Bureau of Investigation ("FBI") as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before February 4, 2008.
- To date, Respondent has not submitted a full set of fingerprints to the 5. Department.

- 6. Respondent acknowledges that this Consent Order is an administrative action that the Department will report to the National Association of Insurance Commissioners (NAIC). Respondent further acknowledges that she must report this administrative action to
