The Savings Bank Life Insurance Company of Massachusetts ("Respondent"), a Massachusetts domiciled insurer, received its certificate of authority to transact life insurance. 14 effective March 19, 2008. 15 16 2. Massachusetts General Laws ("MGL") Title XXII, Chapter 175, Section 151 and 17 the Massachusetts Schedule of Fees prescribe a special deposit in the amount of \$100,000 to 18 be made by an Arizona insurer as a condition of transacting life insurance business in Massachusetts. 19 20 3. The special deposit is to be deposited with the Massachusetts state treasurer in 21 exclusive trust for the benefit and security of the policyholders of the Commonwealth of 22 Massachusetts, and is in addition to the general deposit required by MGL Title XXII, Chapter 23 175, Section 151.

1	4. A.R.S. § 20-230(A) requires a retaliatory deposit with the State of Arizona.
2	CONCLUSIONS OF LAW
3	The Director has jurisdiction over this matter.
4	2. Grounds exist for the Director to require the Respondent to make a retaliatory
5	deposit with the State of Arizona. A.R.S. § 20-230(A).
6	ORDER
7	IT IS ORDERED requiring Respondent to, within 30 days of the date of this Order,
8	establish and maintain a retaliatory deposit in the amount of \$100,000 with the State of
9	Arizona for the sole benefit and security of its Arizona policyholders.
