The State of Arizona Department of Insurance ("Department") has received evidence that Matthew Allen Wright ("Respondent") violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

- Respondent is, and was at all material times licensed as a resident accident/health/life producer, Arizona license number 123374, which license expires May 31, 2009.
- 2. On or about January 14, 2008, Respondent falsified the insurance credit score information on the automobile insurance applications for Leonard Pacaro and Del Harris in order to lower their premium rates.

CONCLUSIONS OF LAW

1. The Director has jurisdiction over this matter.

- 2. Respondent's conduct as described above constitutes intentionally misrepresenting the terms of an actual or proposed insurance contract or application for insurance within the meaning of A.R.S. § 20 -295(A)(5).
- 3. Respondent's conduct as described above constitutes using fraudulent, coercive or dishonest practices, or demonstrating incompetence, untrustworthiness or financial irresponsibility in the conduct of business in this state or elsewhere within the meaning of A.R.S. § 20 -295(A)(8).
- 4. Grounds exist for the Director to suspend, revoke, or refuse to renew Respondent's insurance license, impose a civil penalty and/or order restitution pursuant to A.R.S. §§20-295(A) and 20-295(F).

ORDER

IT IS HEREBY ORDERED THAT:

- Respondent's license is suspended for 10 continuous business days effective immediately upon entry of this Order.
- 2. Respondent shall pay a civil penalty in the amount of \$500.00 to the Director for deposit in the State General Fund in accordance with A.R.S. § 20-295(G).

Respondent acknowledges that the acceptance of this Consent Order by the Director is solely to settle this matter against him and does not preclude any other agency, officer, or subdivision of this state from instituting civil or criminal proceedings as may be appropriate now or in the future nor does it preclude the Department from instituting proceedings not related to this matter as may be appropriate now or in the future.
