- 2. On November 6, 2007, Respondent pled guilty and allocuted to three felony counts of Mail Fraud and Money Laundering involving securities transactions in the United States District Court, District of Arizona, Case #07-01867-TUC-JMR (CRP).

## **CONCLUSIONS OF LAW**

- 1. The Director has jurisdiction over this matter.
- 2. Respondent's conduct as described above constitutes using fraudulent, coercive or dishonest practices, or demonstrating incompetence, untrustworthiness or financial
