) **ORDER SUMMARILY SUSPENDING**
) **BAIL BOND AGENT LICENSE**
) **AND NOTICE OF OPPORTUNITY**
) **FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Steven Dale Gingerich** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Steven Dale Gingerich ("Respondent") is licensed as a bail bond agent, Arizona license number 892556 which expires on March 31, 2011.

3. On May 27, 2008, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled 30 days after receipt of the notice by the Department.
