ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING
·

The Arizona Department of Insurance (the "Department") alleges that **Jennifer Lynn Huston** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 1. Jennifer Lynn Huston ("Respondent") is licensed as a bail bond agent, Arizona license number 869538 which expires on February 28, 2010.
- 2. Respondent's addresses of record with the Department are: Majestic Bail Bonds, 1645 W. Valencia Rd., Suite 109-277, Tucson, Arizona 85746 (business); and 7127 S. Providence Dr., Tucson, Arizona 85757 (residence).
- 3. On March 11, 2008, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled on March 29, 2008.

- 4. On April 30, 2008, the Department sent Respondent a letter at her business address of record, notifying Respondent that she had failed to maintain a surety bond as required by law.
- 5. As of March 29, 2008, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.
 - 6. The public health, safety and welfare imperatively require emergency action.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction.
- 2. Respondent's conduct constitutes a violation of the requirement that each bail bond agent maintain in force while license a bond in favor of this State executed by a surety insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.
- 3. Grounds exist to order a summary suspension within the meaning of A.R.S. § 41-1092.11(B).

ORDER

IT IS HEREBY ORDERED THAT:

1. Respondent's license is summarily suspended effective immediately.
