**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Roseanna Michelle Martin** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Roseanna Michelle Martin ("Respondent") is licensed as a bail bond agent, Arizona license number 210367 which expires on August 31, 2009.
2. Respondent's addresses of record with the Department are: 132 S. Central Ave., #236, Phoenix, Arizona 85004 (business); P.O. Box 27716, Tucson, Arizona 85726-7716 (mailing); and 2420 E. Calle Lena Verde, Tucson, Arizona 85706 (residence).
3. On September 30, 2008, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled on October 22, 2008.
