- 4. On November 6, 2008, the Department sent Respondent a letter at her mailing address of record, return receipt requested, notifying Respondent that she had failed to maintain a surety bond as required by law.
- 5. As of October 22, 2008, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.
 - 6. The public health, safety and welfare imperatively require emergency action.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction.
- 2. Respondent's conduct constitutes a violation of the requirement that each bail bond agent maintain in force while license a bond in favor of this State executed by a surety insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.
- 3. Grounds exist to order a summary suspension within the meaning of A.R.S. § 41-1092.11(B).

ORDER

IT IS HEREBY ORDERED THAT:

1. Respondent's license is summarily suspended effective immediately.
