CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that Amy Marie King ("Respondent") violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent is, and was at all material times licensed as an Arizona resident Casualty and Property Producer, Arizona license number 44761, which expires on July 31, 2012. Respondent operated under the assumed business name of Everette & Associates, LLC ("Everette").

2. On June 11, 2008, Respondent converted \$813.29 of Everette funds for premium payment to Allstate Insurance Company ("Allstate") for policy #986432319 to her personal use.

3. On July 16, 2008, Respondent converted \$767.24 of Everette funds for premium payment to Allstate for policy #986473480 to her personal use.

CONSENT TO ORDER

2 1. Respondent has reviewed the foregoing Findings of Fact, Conclusions of Law
3 and Order.

4 2. Respondent admits the jurisdiction of the Director of Insurance, State of Arizona,
5 and admits the foregoing Findings of Fact and consents to the entry of the foregoing
6 Conclusions of Law and Order.

7 3. Respondent is aware of her right to notice and a hearing at which she may be
8 represented by counsel, present evidence and examine witnesses. Respondent irrevocably
9 waives her right to such notice and hearing and to any court appeals relating to this Consent
10 Order.

11 4. Respondent states that no promise of any kind or nature whatsoever, except as
12 expressly contained in this Consent Order, was made to her to induce her to enter into this
13 Consent Order and that she has entered into this Consent Order voluntarily.


14 5. Respondent acknowledges that the acceptance of this Consent Order by the
15 Director is solely to settle this matter against her and does not preclude any other agency,
16 officer, or subdivision of this state including the Department from instituting civil or criminal
17 proceedings as may be appropriate now or in the future.
