

1 a surety bond as required by law. The Post Office returned the signed green card to the
2 Department indicating Respondent had signed the card on January 7, 2009.

3 5. As of February 1, 2009, Respondent has not maintained a bond in favor of this
4 State executed by a surety insurer authorized to do business in this State.

5 6. The public health, safety and welfare imperatively require emergency action.

6 **CONCLUSIONS OF LAW**

7 1. The Director has jurisdiction.

8 2. Respondent's conduct constitutes a violation of the requirement that each
9 service company maintain in force, while registered or until such time as all of the service
10 company contractual obligations are satisfied, a bond in favor of this State executed by a
11 surety insurer authorized to do business in this State, within the meaning of A.R.S. §§ 20-
12 1095.03 and 20-1095.04.


13 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §§
14 41-1092.11(B) and 20-1095.08.

15 **ORDER**

16 IT IS HEREBY ORDERED THAT:

17 1. Respondent's Arizona service company permit and authority to do business in
18 this state is summarily suspended effective immediately.
