CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Matthew Peter Anderson** violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Matthew Peter Anderson ("Anderson" or "Respondent") is, and was at all material times, licensed by the Arizona Department of Insurance ("Department") as an Arizona accident/health, life, property & casualty and variable life and variable annuities producer, Arizona license number 894533, which expires on September 30, 2010.
2. On or about February 2, 2008, Respondent contracted with Country Financial to transact insurance on its behalf in Arizona.
3. Between June and July 2009, Respondent falsified and submitted 15 home owners applications to Country Financial.

CONCLUSIONS OF LAW

1. The Director has jurisdiction over this matter.

1 3. Respondent is aware of his right to notice and a hearing at which he may be
2 represented by counsel, present evidence and examine witnesses. Respondent
3 irrevocably waives his right to such notice and hearing and to any court appeals relating to
4 this Consent Order.

5 4. Respondent states that no promise of any kind or nature whatsoever, except
6 as expressly contained in this Consent Order, was made to him to induce him to enter into
7 this Consent Order and that he has entered into this Consent Order voluntarily.

8 5. Respondent acknowledges that the acceptance of this Consent Order by the
9 Director is solely to settle this matter against him and does not preclude any other agency,
10 officer, or subdivision of this state including the Department from instituting civil or criminal
11 proceedings as may be appropriate now or in the future not related to this matter.

13 6. Respondent acknowledges that this Consent Order is an administrative action
14 that the Department will report to the National Association of Insurance Commissioners
15 (NAIC). Respondent further acknowledges that he must report this administrative action to
16 any and all states in which he holds an insurance license and must disclose this
17 administrative action on any license application.
