CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Marlene C. Baquet and A B C Insurance and Financial Services, Inc.** ("Respondents") violated provisions of Title 20, Arizona Revised Statutes. Respondents wish to resolve this matter without the commencement of formal proceedings, and admit the following Findings of Fact are true and consent to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Marlene C. Baquet ("Baquet") is, and was at all material times, licensed as an Arizona resident accident/health, life, property and casualty insurance producer, Arizona license number 132086, which expires January 31, 2010.

2. A B C Insurance and Financial Services, Inc. ("ABC") is, and was at all material times, licensed as an Arizona resident accident/health, life, property and casualty insurance producer, Arizona license number 126338, which expires February 28, 2010. Baquet is the owner/operator of ABC.

3. Between September 29, 2009 and October 2, 2009, Respondents parked a van, owned by Baquet, at 1955 W. Grant Road in Tucson Arizona bearing a banner advertising "Anthony Figueroa's Allstate Rates up 17%. Save now with Baquet Insurance 520-620-0222."

3 6. Respondents acknowledge that this Consent Order is an administrative action that  
4 the Department will report to the National Association of Insurance Commissioners (NAIC).  
5 Respondents further acknowledge that they must report this administrative action to any and  
6 all states in which they hold an insurance license and must disclose this administrative  
7 action on any license application.

8 7. Marlene C. Baquet represents that she is owner/operator of A B C Insurance and  
9 Financial Services, Inc. and as such is authorized to enter into this Consent Order on its  
10 behalf.


