The Arizona Department of Insurance (the "Department") alleges that **Pioneer Management Systems, Inc.** has violated provisions of Arizona Revised Statutes ("A.R.S."),

Title 20. In light of the serious nature of these allegations, the Director of Insurance for the

State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 1. Pioneer Management Systems, Inc. ("Respondent") holds a certificate of registration as a third party administrator in Arizona.
- Respondent's address of record with the Department is: 123 Interstate Drive,
 P.O. Box 9040, West Springfield, MA 01090.
- 3. On September 10, 2008, the insurer holding Respondent's surety bond notified the Department that Respondent's third party administrator bond was to be cancelled on October 10, 2008.
- 4. As of October 10, 2008, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.

5. The public health, safety and welfare imperatively require emergency action.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction.
- 2. Respondent's conduct constitutes a violation of the requirement that each administrator possess and maintain a surety bond in a form acceptable to the director and issued by a corporate surety authorized to transact business in this State, within the meaning of A.R.S. § 20-485.10.
- 3. Grounds exist to order a summary suspension within the meaning of A.R.S. § 41-1092.11(B).

ORDER

IT IS HEREBY ORDERED THAT:

1. Respondent's third party administrator certificate of registration is summarily suspended effective immediately.
