- 1. Catholic Family Life insurance ("Petitioner") is a Wisconsin domiciled insurance company that received its certificate of authority to transact life and disability insurance in Arizona effective December 5, 1985.
- 2. Petitioner, the non-surviving entity, merged into Catholic Knights (CK), NAIC No. 56030, the surviving entity, a Wisconsin domiciled insurer effective April 1, 2010. CK is authorized to transact insurance in Arizona. Petitioner voluntarily surrendered its certificate of authority to the Department.
- 3. The Insurance Commissioner of Wisconsin approved the merger of Petitioner into CK on March 22, 2010.
- 4. Petitioner has no insurance obligations under any policy of insurance to any policyholders or claimants who are residents of Arizona.
