- 1. Wright & Co. ("Respondent") holds a certificate of registration as a life and health administrator in Arizona.

- 3. On February 10, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's life and health administrator bond was to be cancelled on March 24, 2010.
- 4. As of March 24, 2010, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.
- 5. On May 11, 2010, the Department issued an Order Summarily Suspending Life and Health Administrator Certificate of Registration and Notice of Opportunity for Hearing In the Matter of Wright & Co. (Arizona Certificate # 2307); Docket No. 10A-067-INS.
- 6. On or about July 26, 2010, Respondent provided evidence to the Department that it had procured a new bond.
