The State of Arizona Department of Insurance ("Department") has received evidence that Get Out Bail Bonds, LLC dba Get Out of Jail Bail Bonds, We Pick You Up Bail

FINDINGS OF FACT

- 1. Get Out Bail Bonds, LLC ("Get Out") is an Arizona domestic limited liability company incorporated on April 1, 2010. Kristin Marie Roossin ("Roossin") is a manager and member of Get Out.
- 2. Roossin is licensed as an Arizona resident bail bond agent, Arizona license # 964544, which expires on April 30, 2014. The Department first licensed Roossin on April 19, 2010.
 - 3. Between April 12, 2010, and May 5, 2010, Get Out wrote 170 bail bonds.
- 4. On May 6, 2010, Get Out became licensed by the Department as a resident bail bond agent, Arizona License # 965627, which expires on May 31, 2014. Roossin is the Designated Responsible Licensed Producer for Get Out.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction over this matter.
- 2. Respondent's conduct as described above constitutes a violation of the requirement that a person shall not act as a bail bond agent in this state unless the person is licensed by the director, within the meaning of A.R.S. § 20-340.01.
- 3. Grounds exist for the Director to suspend, revoke, or refuse to renew Respondents' insurance licenses, impose a civil penalty and/or order restitution pursuant to A.R.S. §§20-295(A), (B) and (F) as applied to bail bond agents under A.R.S. § 20-340.06.

ORDER

IT IS HEREBY ORDERED THAT

1. Respondents shall immediately pay a civil penalty in the amount of \$1,000.00 for deposit into the State General Fund..
