8 The State of Arizona Department of Insurance ("Department") has received evidence
 9 that **Cynthia Louise Hurtado** has violated provisions of Title 20, Arizona Revised Statutes
 10 ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal
 11 proceedings, and admits the following Findings of Fact are true and consents to entry of the
 12 following Conclusions of Law and Order.

FINDINGS OF FACT

- 13 1. Cynthia Louise Hurtado ("Respondent") is, and was at all material times licensed
 14 as a resident accident/health and life producer, Arizona license number 938531 which expires
 15 June 30, 2012.
- 16 2. Respondent's mailing, business and residence addresses of record with the
 17 Department are: c/o Primerica, 1481 N. Eliseo Felix Jr. Way, Suite 220, Avondale, Arizona
 18 85323 (business and mailing); 21769 N. Allen Ct., Maricopa, Arizona 85238 (residence).
- 19 3. On or about February 20, 2009, the Department issued to Respondent an
 20 insurance license as a resident accident/health and life producer, Arizona license number
 21 938531.
- 22 4. On July 29, 2009, the Department notified Respondent by mail at her
 23 business/ mailing address of record that her fingerprint card had been processed and returned
 by the Arizona Department of Public Safety (DPS) as illegible. The Department requested a
 replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement
 Form" on or before August 28, 2009.



3 6. Respondent acknowledges that this Consent Order is an administrative action
4 that the Department will report to the National Association of Insurance Commissioners
5 (NAIC). Respondent further acknowledges that she must report this administrative action to
6 any and all states in which she holds an insurance license and must disclose this
7 administrative action on any license application.
