ORDER

9 Based upon reliable evidence provided to the Director of Insurance by the Assistant
10 Director of the Financial Affairs Division of the Arizona Department of Insurance
11 ("Department"), the Director finds as follows:

FINDINGS OF FACT

13 1. Auto Club Property-Casualty Insurance Company ("Petitioner") is an Iowa
14 domiciled insurance company that received its certificate of authority to transact disability
15 insurance in Arizona effective March 30, 1977.

16 2. Petitioner seeks to withdraw from the insurance business in Arizona and has
17 voluntarily surrendered its certificate of authority to the Director.

18 3. Petitioner has no obligations under any policy of insurance to any policyholders
19 or claimants who are residents of Arizona.

20 4. Petitioner is not the subject of any pending investigation or market conduct
21 examination and does not owe this Department any filings or fees.

22 5. Petitioner has a \$100.00 deposit with the Insurance Examiners' Revolving Fund
23 ("IERF").

1 **CONCLUSIONS OF LAW**

2 Petitioner has complied with the provisions of A.R.S. § 20-217 and with A.A.C. R20-6-
3 303 relating to the surrender of its Certificate of Authority and its withdrawal from the
4 insurance business.

5 **ORDER**

6 1. The surrender of the Petitioner's certificate of authority is accepted.

7 2. The Department shall refund to the Petitioner the sum of \$100.00 that was
8 previously credited to the IERF pursuant to A.R.S. § 20-159.
