- 3. On or about February 26, 2010, the Department issued to Respondent an insurance license as a resident life producer, Arizona license number 961479.

On June 1, 2010, the Department notified Respondent by mail at her business/mailing address of record that her fingerprint card had been processed and returned by the Arizona Department of Public Safety (DPS) as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before July 1, 2010.

2. The hearing, Docket #10A-200-INS, scheduled for March 10, 2011, at 8:00 a.m. is vacated.
