**ORDER REINSTATING  
LIFE AND HEALTH ADMINISTRATOR  
CERTIFICATE OF REGISTRATION**

**FINDINGS OF FACT**

1. Ben-E-Lect Corporation ("Respondent") holds a certificate of registration as a life and health administrator in Arizona.

2. Respondent's address of record with the Department is: P.O. Box 7809, 5429 Avenida De Los Robles, #A, Visalia, California 93291-7809.

3. On November 29, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's life and health administrator bond was to be cancelled in 30 days or on December 29, 2010.

4. As of December 29, 2010, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.

5. On January 13, 2011, the Department issued an Order Summarily Suspending Life and Health Administrator Certificate of Registration and Notice of Opportunity for Hearing In the Matter of Ben-E-Lect Corporation (Arizona Certificate # 2264); Docket No. 11A-002-INS.

6. On or about February 7, 2011, Respondent provided evidence to the Department that it had procured a new bond.

1 CONCLUSIONS OF LAW

2 1. The Director has jurisdiction.


3 2. Respondent's conduct constitutes compliance with the requirement that each  
4 administrator possess and maintain a surety bond in a form acceptable to the director and  
5 issued by a corporate surety authorized to transact business in this State, within the meaning  
6 of A.R.S. § 20-485.10.

7 ORDER

8 IT IS HEREBY ORDERED THAT:

9 1. With the submission of the statutorily required surety bond, the Department  
10 hereby reactivates Respondent's Arizona Certificate of Registration, # 2264, as of the date of  
11 this Order.
