The State of Arizona Department of Insurance ("Department") has received evidence that **Concetta Connie Palmiotto** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Concetta Connie Palmiotto ("Respondent") is, and was at all material times licensed as a resident life producer, Arizona license number 961389, which expires September 30, 2013.
2. Respondent's mailing, business and residence addresses of record with the Department are: 8009 E. Saddle Horn Rd., Scottsdale, Arizona 85255 (business and residence); c/o Primerica Financial, 16425 N. Pima Rd., #325, Scottsdale, Arizona 85260 (mailing).
3. On or about February 25, 2010, the Department issued to Respondent an insurance license as a resident life producer, Arizona license number 961389.
4. On June 1, 2010, the Department notified Respondent by mail at her mailing address of record that her fingerprint card had been processed and returned by the Arizona Department of Public Safety (DPS) as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before July 1, 2010.





1           6.     Respondent acknowledges that this Consent Order is an administrative action  
 2 that the Department will report to the National Association of Insurance Commissioners  
 3 (NAIC). Respondent further acknowledges that she must report this administrative action to  
 4 any and all states in which she holds an insurance license and must disclose this  
 5 administrative action on any license application.
