CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Infinity Title Agency, LLC** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Infinity Title Agency, LLC ("Infinity Title" or "Respondent") is, and was at all material times licensed as a resident title agent, Arizona license number 964492, which expires April 30, 2014.
2. Respondent's business address of record with the Department is: 1 E. Camelback Road, Phoenix, Arizona 85012.
3. TSA Ventures, LLC is a Member of Infinity Title.
4. On or about April 19, 2010, the Department issued to Respondent an insurance license as a resident title agent, license number 964492.
5. On August 11, 2010, the Department notified Respondent by mail at its business address of record c/o Lynn Kramer that Lynn Kramer's fingerprint card had been processed and returned by the Federal Bureau of Investigation ("FBI") as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before September 11, 2010.

2 **ORDER**

3 IT IS HEREBY ORDERED THAT:

4 1. Respondent shall immediately submit to the Department a full set of fingerprints  
5 and an Illegible Fingerprint Replacement Form for Lynn Kramer.

6 2. Respondent shall immediately pay to the Department a civil money penalty in the  
7 amount of \$250.00.

8 3. The hearing, Docket #11A-009-INS, scheduled for April 13, 2011, at 8:00 a.m. is  
9 vacated.

15 **CONSENT TO ORDER**

16 1. Respondent has reviewed the foregoing Findings of Fact, Conclusions of Law  
17 and Order.

18 2. Respondent admits to the jurisdiction of the Director of Insurance, State of  
19 Arizona, and admits the foregoing Findings of Fact and consents to the entry of the foregoing  
20 Conclusions of Law and Order.

21 3. Respondent is aware of its right to notice and a hearing at which it may be  
22 represented by counsel, present evidence and examine witnesses. Respondent irrevocably  
23 waives its right to such notice and hearing and to any court appeals relating to this Consent  
Order.

1 4. Respondent states that no promise of any kind or nature whatsoever, except as  
2 expressly contained in this Consent Order, was made to it to induce it to enter into this  
3 Consent Order and that it has entered into this Consent Order voluntarily.

4 5. Respondent acknowledges that the acceptance of this Consent Order by the  
5 Director is solely to settle this matter against it and does not preclude any other agency,  
6 officer, or subdivision of this state including the Department from instituting civil or criminal  
7 proceedings as may be appropriate now or in the future not related to this matter.

8 6. Respondent acknowledges that this Consent Order is an administrative action  
9 that the Department will report to the National Association of Insurance Commissioners  
10 (NAIC). Respondent further acknowledges that it must report this administrative action to  
11 any and all states in which it holds an insurance license and must disclose this administrative  
12 action on any license application.

13 7. Cobra Collier, represents that she is Vice President of Title Security Agency of  
14 Arizona, Inc., which is the sole member and manager of TSA Ventures, LLC which is a  
15 member of Infinity Title Agency, LLC and, as such is authorized to enter this Consent Order on  
16 Respondent's behalf.
