The State of Arizona Department of Insurance ("Department") has received evidence that **Old West Bail Bonds LLC** and **Sandra Margot Escott** ("Respondent's") violated provisions of Title 20, Arizona Revised Statutes. Respondents wish to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

## FINDINGS OF FACT

- 1. Old West Bail Bonds LLC and Sandra Margot Escott (Respondent Sandra Margot Escott) was, and at all material times, licensed as Arizona resident, Bail Bonds Agent Arizona license number 873577, which expires April 30, 2014. The Manager and Designated Responsible Licensed Producer of record is Sandra Margot Escott.
- 2. On or about September 2, 2008, Ms. Sandra Escott filed the Articles of Organization of Old West Bail Bonds LLC with the Arizona Corporation Commission, which were approved September 4, 2008.
- 3. Ronald Escott and Sandra Escott are listed as Member's of Old West Bail Bonds LLC with the Arizona Corporation Commission.

- Respondent admits the jurisdiction of the Director of Insurance, State of Arizona, 2. and admits the foregoing Findings of Fact and consents to the entry of the foregoing Conclusions of Law and Order.
- 3. Respondent is aware of her rights to notice and hearing at which she may be represented by counsel, present evidence and examine witnesses. Respondent irrevocably waives her righst to such notice and hearing and to any court appeals relating to this Consent Order.
- Respondents state that no promise of any kind or nature whatsoever, except as 4. expressly contained in this Consent Order, was made to her to induce her to enter into this Consent Order and that she has entered into this Consent Order voluntarily.
- Respondent acknowledge that the acceptance of this Consent Order by the 5. Director is solely to settle this matter against her and does not preclude any other agency, including the Department, officer, or subdivision of this state or this agency from instituting civil or criminal proceedings as may be appropriate now or in the future.
- 6. Respondent acknowledges that this Consent Order is an administrative action that the Department will report to the National Association of Insurance Commissioners (NAIC). Respondent further acknowledges that she must report this administrative action to any and all states in which she holds an insurance license and must disclose this administrative action on any license application.
