FINDINGS OF FACT

1. On March 3, 2011, the Arizona Department of Insurance ("Department") filed an Order to Cease and Desist in the above captioned matter (the "Department's Order").

2. The Department's Order is effective and remains in full force and effect until otherwise stayed, modified, vacated or set aside.

3. On March 15, 2011, Public Claims Adjusters & Associates, Inc. ("PCAA") filed an appeal of the Department's Order stating that PCAA was licensed as an adjuster in Arizona.

4. Upon further investigation, the Department discovered that PCAA is licensed as an adjuster but that a data entry error recorded its name erroneously in the Department's licensing database. It also determined that because PCAA was a licensed entity, Leonard Adrian Rougemont was not holding himself out as an adjuster.

CONCLUSIONS OF LAW

1. The Director has jurisdiction over this matter.


