THEREFORE IT IS ORDERED granting the stay of the Department's Order and Decision.

IT IS FURTHER ORDERED because Respondent's renewal application was not timely, its Appeal does not stay the expiration of Respondent's Arizona license, number 882463, which expired at midnight on January 31, 2011 and remains expired. Respondent
