The Arizona Department of Insurance ("Department") has received evidence that CarSafe, LLC has unlawfully offered service contracts in the State of Arizona. Accordingly, the Director of Insurance of the State of Arizona (the "Director") makes the following Findings of Fact and Conclusions of Law and enters the following Order pursuant to A.R.S. §§ 20-1095.09(B).

FINDINGS OF FACT

- CarSafe, LLC ("Respondent" or "CarSafe") is an Oklahoma limited liability 1. company¹ that is registered in Arizona as a foreign corporation. CarSafe offers service contracts to Arizona residents. CarSafe's addresses are: 1529 S. Old Hwy 94, #110, St. Charles, MO 63303; and c/o Corporation Service Company, 2338 W. Royal Palm Rd., Ste J, Phoenix, AZ 85021 (Statutory Agent).
- 2. CarSafe does not hold a permit to offer service contracts in the State of Arizona.
 - CarSafe is not exempt from the permit requirement. 3.
- 4. Sometime prior to May 26, 2011, CarSafe mailed a solicitation offering an extended auto warranty service contract to an Arizona resident.
- 5. On or about November 8, 2010, the Missouri Attorney General sued CarSafe for selling insurance in Missouri without a state license.

CarSafe's Oklahoma status is listed as inactive.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction over this matter.
- 2. Respondent's conduct, as alleged above, constitutes offering service contracts without a permit, within the meaning of A.R.S. § 20-1095.01(A).
- 3. Respondent is not exempt from the permit requirement, within the meaning of A.R.S. § 20-1095.02(A).
- 4. Grounds exist for the Director to order Respondent to cease and desist its violation pursuant to A.R.S. § 20-1095.09(B).

ORDER

IT IS THEREFORE ORDERED:

- 1. Respondent shall immediately cease and desist from offering or soliciting warranty service contract applications, taking or proposing to make any warranty service contract, taking or receiving any application for warranty service contracts, taking or collecting any premium, fees, commission, or any other consideration for any warranty service contract, issuing or delivering warranty service contracts to residents of this state, or otherwise offering or issuing service contracts to Arizona residents.
- 2. Respondent shall pay all valid claims arising out of acts covered by any and all service contract issued by them to Arizona residents for so long as such claims may legally be brought against the contract holders.
- 3. This Order shall become effective immediately and shall remain in full force and effect until otherwise stayed, modified, vacated or set aside.

NOTICE OF OPPORTUNITY FOR HEARING

Pursuant to Title 20 of the Arizona Revised Statutes, Respondents are hereby notified that they may request a hearing pursuant to A.R.S. § 20-161 to contest the order to

cease and desist.
