**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Andrew Jacob Gray, Sr.** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Andrew Jacob Gray, Sr. ("Respondent") is licensed as a resident bail bond agent, Arizona license number 976796 which expires on November 30, 2013.
2. Respondent's addresses of record are: 3050 S. Country Club Drive, Mesa, Arizona 85210 (business and mailing); and 9431 E. Coralbell, Lot 35, Mesa, Arizona 85208 (residence).
3. On December 13, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective thirty (30) days after receipt of the notice by certified mail.

1 4. On December 16, 2010, the Department notified Respondent that the surety
2 holding Respondent's bond was cancelling the bond effective January 16, 2011.

3 5. To date, Respondent has failed to replace the cancelled surety bond.

4 6. Therefore, as of January 16, 2011, Respondent has not maintained a bond in
5 favor of this State executed by a surety insurer authorized to do business in this State.

6 7. The public health, safety and welfare imperatively require emergency action.

7 **CONCLUSIONS OF LAW**

8 1. The Director has jurisdiction.

9 2. Respondent's conduct constitutes a violation of the requirement that each bail
10 bond agent maintain in force while license a bond in favor of this State executed by a surety
11 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

12 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §
13 41-1092.11(B).

14 **ORDER**

15 IT IS HEREBY ORDERED THAT:

16 1. Respondent's bail bond agent license, Arizona license number # 976796, is
17 summarily suspended effective immediately.


