ORDER REINSTATING  
BAIL BOND AGENT  
LINE OF AUTHORITY

FINDINGS OF FACT

1. Andrew Neal Ogden ("Respondent") is licensed as a resident life producer and bail bond agent, Arizona license number 902346, which expires on March 31, 2015.

2. Respondent's address of record is: 3610 E. Penny Lane, Cottonwood, Arizona 86326 (business, mailing and residence).

3. On November 18, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective on December 24, 2010.

4. On November 29, 2010, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective December 24, 2010.

5. Therefore, as of December 24, 2010, Respondent had not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.

1 6. On July 5, 2011, the Department issued an Order Summarily Suspending Bail  
2 Bond Agent Line of Authority and Notice of Opportunity for Hearing In the Matter of Ogden,  
3 Andrew Neal, Docket No. 11A-074-INS.

4 7. On or about September 28, 2011, Respondent provided evidence to the  
5 Department that he had procured a new surety bond.

6 **CONCLUSIONS OF LAW**

7 1. The Director has jurisdiction.


8 2. Respondent's conduct constitutes compliance with the requirement that each bail  
9 bond agent maintain in force while licensed a bond in favor of this State executed by a surety  
10 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

11 **ORDER**

12 IT IS HEREBY ORDERED THAT:

13 1. With the submission of the statutorily required surety bond, the Department  
14 hereby reactivates Respondent's Arizona license # 902346 as of the filing date of this Order.
