**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Sheree Shantelle Olivaz** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Sheree Shantelle Olivaz ("Respondent") is licensed as a resident bail bond agent, Arizona license number 927591 which expires on January 31, 2012.
2. Respondent's addresses of record are: 40 N. Central Ave., #1400, Phoenix, Arizona 85004 (business); c/o Bailanytime, 40 N. Central Ave., #1400, Phoenix, Arizona 85004 (mailing); and 1425 N. 80<sup>th</sup> Lane, Phoenix, Arizona 85043 (residence).
3. On November 10, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective on December 1, 2010.
